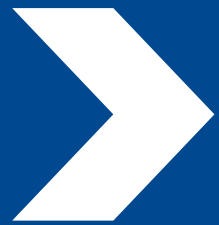

## Entry Requirements

### Short Accelerated Route 1

- Holders of an MBA or congruent master's degree; or
- A bachelor's degree together with 10 years or more very senior banking experience held at an executive level

### Short Accelerated Route 2

- Applicants with a first degree and a high-level professional qualification (such as your AICB Chartered Banker), and senior executive experience for at least 10 years

*Note : The standard full programme requires 8 Core and 4 Optional modules and takes 24 months to complete at **£20,500** (about RM123,000) per person & eligible for £1,500 part-funding to self or part-funded applicants for Autumn 2025 intake only.*



# Assessments & Exams




## Core Modules

Assessed with a 2,000-word assignment due half-way into the semester and a 2-hour examination at the end. The weightage is 40/60 respectively and the passing mark is 50%.

### Examinations

- Computer-based and invigilated remotely
- Strictly 2 hours with 20 minutes reading time
- Exam format varies per module and consists of MCQs and/or essays
- Online Revision Session will be held before each exam
- Access to a test version of the Computer Based exam platform
- Past papers will be made available on the learning platform for practice purposes
- If a student has failed an exam, they can re-sit the paper at a fee of £100 each time up to 3 attempts
- Exams are arranged on one day, globally



## Optional Modules

Project based and wholly assessed on the 3,500-word assignment which is due on the last day of the semester.



# Payments

## **CORPORATE** **Sponsored Students**

  - Effective December 2024, the Bangor Business School will no longer extend discounts for corporate sponsored students

## **SELF OR PART** **Funded Students**

- **Payment Options**
  - Monthly instalments or pay per semester or module with Bangor Business School
  - EPF Account 2 withdrawal – For Malaysians and non-Malaysians below 55 years old
  - 0% Interest Credit Card Instalment Plan with AmBank & Affin Bank
  - Term Loan facilities with flexible repayment schemes with AmBank, Affin Bank & Maybank
- **Autumn 2025 Funding**
  - Individuals may be eligible to receive a part-funded scholarship to the value of £1,500 for the Autumn 2025 intake only. Applicable to full programme applicants only.

# How to Apply

1

Pre-qualification (i.e. route eligibility confirmation through review of CVs) is no longer available with Bangor University. Candidates are asked to explore the various pathways offered based on their qualifications and work experience on the [Bangor University website](#) or [ABS website](#)

2

Once candidates have an idea of their route eligibility, they can apply for the programme through ABS.

3

This can be done by submitting a personal statement, updated CV, reference letter from your relevant employer, copies of official certificates of completed educational qualifications i.e. degree awards and professional qualifications along with official course transcripts and a copy of the main page of your passport to ABS

4

ABS will then submit your application with the supporting documents to the Bangor Business School Application Portal for their review and further processing. An Offer letter will be issued if the application is complete. The candidate will then find out their route eligibility and the accompanying fees.

5

While an applicant's route and eligibility will be subject to final confirmation by the Bangor Business School, ABS can use their discretion to make recommendations to the School on behalf of an applicant.
